These trips will let you enjoy the natural, impressive beauty of Patagonia and live a great adventure in the end of the world. Onboard surprisingly comfortable boats with expert crew and guides. Designed to navigate the Patagonian fjords, they can sail through the most remote corners of Tierra del Fuego and reach where larger boats cannot. Each vessel has only 100 cabins (200 passengers maximum + 64 crew members) all with an exterior window and comfortable common lounges. On board, you will experience Nature and wildlife as never before —penguins, seabirds and sea lions, the warm shades of the Patagonian sunset, beautiful snow-covered mountains, while navigating by the Cape of Horn.




Cabin Plan








DARWIN DECK




CABO DE HORNO DECK

RATES AND DEPARTURES

The Company reserves the right to modify the rates and departures published in these pricing conditions without prior notice, which will be valid from the date of publication.

CHECK-IN, BOARDING, DEPARTURE AND ARRIVAL

Boarding, departure, and arrival times are approximate. Passengers must comply with the check-in schedule and show up at the required times. Check-in, boarding, departure and arrival times may be delayed due to weather conditions by order of the maritime authority, for sanitary measures adopted by the Company or put in place by the authorities due to the welfare, health and safety of one or more passengers or due to an act of authority or other event constituting force majeure or a fortuitous event. The Company shall not be liable and affected passengers shall not be entitled to any compensation in these circumstances.

Likewise, in case of the delayed arrival of the vessel, the Company may need to delay the check-in, boarding and departure of the ship on the next trip. The Company will not be liable for any loss resulting from such delays and will not be required to compensate the affected passengers.

RESERVATIONS, DEPOSITS AND PAYMENTS

A US \$300 deposit per person is required to secure a reservation. Full payment of the ticket price must be received by the Company no later than 60 days prior to departure (this payment deadline does not apply to promotions and/or special trips).

CANCELLATION

The reservation can be canceled:

- Up to 120 days before departure without incurring any penalties, in which case the Company will refund the total value of what was received as at the date of cancellation.
- From the 119th day prior to departure, incurring the following penalties:
 - Between 119 and 60 days (both inclusive) before departure: US \$300, value of the deposit.
 - Between 59 and 50 days (both inclusive) before departure: 25% of the value of the reservation.
 - Between 49 and 40 days (both inclusive) before departure: 50% of the value of the reservation.
 - Between 39 and 30 days (both inclusive) before departure: 75% of the value of the reservation.
 - From the 29th (inclusive) before departure: 100% of the value of the reservation.

The corresponding penalties will be applied as soon as the Company receives notification of cancellation in writing.

The Company may cancel one or more voyages due to force majeure or acts of God, i.e., the measures imposed by the national authorities in the port of departure or landfall that prevent the departure or landfall and/or the restrictions imposed by the national or international authorities that restrict or prevent the access of passengers to the port of departure or from carrying out cruise voyages for leisure purposes. In the event of the cancellation of a trip for any of the above-mentioned reasons, the Company shall only be obliged to reimburse the value of the amount paid for the reservation, being deemed understood that any indemnity action for any reason, including consequential damages, loss of profit or moral damages, has been waived by the mere fact of making the reservation. The waiver shall also apply in case of the rescheduling of the voyage.

NOTE

The trips described in the itineraries are usually possible. Notwithstanding the foregoing, the Company reserves the right to alter, change or disregard part of this itinerary without prior notice, whether motivated by the welfare and safety of passengers, for the proper preservation of the environment or due to any extraordinary circumstance, fortuitous event or force majeure. Furthermore, the departure or arrival of vessels may be subject to possible changes. Thus, it is not possible to guarantee bird and animal sightings, since the precise location may change.
